Objectives and investment policy

Objectives

The target of investment activities is, through active asset management and pursuant to the Act on Common Funds and the regulations, to achieve a return that exceeds the return of the benchmark index.

Investment policy

The assets are invested in publicly traded equities and equity-linked securities whose issuer is a company that is Finnish, operates in Finland, is listed in Finland or is highly dependent on the Finnish economy. The fund aims to focus on companies that pay high dividends and companies that are value companies whose market value is low in relation to their book value of equity. The returns on the fund's investments, such as dividends and interest, will be reinvested. The fund's base currency is the euro.

The fund is categorized as 6. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

It is generally expected that the fund's holdings, and therefore its performance, may differ from those of the benchmark, although the fund has a narrow investment universe. The fund is suitable for investors who seek high returns and asset value increases, while also tolerating substantial value fluctuations or even decreases. The fund is suitable as part of a diversified investment portfolio. As a result of the concentrated investment universe of the fund, its 'Active share' -figure may be low. Investors may subscribe for and redeem fund units on every banking day.


