#### Objectives and investment policy

#### Objectives

The objective of this fund is to achieve long-term investment growth, while applying a balanced asset allocation strategy. The share class is accumulating.

#### Investment policy

The fund invests globally in bonds and equities through open-ended UCITS ETFs and Index UCITS funds.

Screening in accordance with the RI (Responsible Investments) policy of the fund does not apply to this fund's investments.

The fund invests indirectly in both bonds and equities with a strategic allocation of 65% in bonds and 35% in equities. The actual allocation will vary from this strategic allocation. The allocation to bonds shall as

a minimum be 40% and must not exceed 80%. The allocation to equities shall as a minimum be 20% and must not exceed 60%.

The modified duration of the fund's investments in bonds, including cash holdings, must be at least 3 years.

At least 90% of the fund's investments in bonds must be denominated in or hedged to EUR.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.


